INTRODUCTION TO FEES

Concept Fertility Centre and Day Hospital are proud to be able to offer Western Australians the most comprehensive and economical fertility treatment in the State. We understand the large financial commitment involved in ART* treatment and therefore endeavour to be as transparent as possible with our fees and charges and as flexible as possible with our payment options.

We encourage you to ask questions and seek clarification to gain a clear understanding of your financial obligations. Our accounts team are on hand to assist and are happy to help you with any questions you may have.

FEES ARE MADE UP OF THREE COMPONENTS

HEALTH INSURANCE COVER

MEDICARE REBATEABLE ITEMS

ART treatments that are medically

Medicare items attract a rebate for services eligible to receive Medicare. Fees that attract a Medicare rebate are indicated in this schedule along with an cost once a rebate has been applied.

When the Medicare Safety Net (explained below) is reached, the estimated out of pocket expense reduces further.

The listed costs are therefore a more realistic indication of your financial outlay for services once Medicare rebates have been applied.

Private Health Insurance (PHI) applied to required, with an MBS item number, may reduce or sometimes eliminate the costs estimation of the expected out-of-pocket associated with the inpatient procedural components of your cycle, including your surgeon, anaesthetist and your hospital theatre and accommodation fees. An excess payment may apply, dependent on your PHI policy. PHI eligible services are noted within the fee schedule by the following symbol:

Out-of-pocket expenses are the actual costs that you will pay for all services required for your treatment within a cycle, after Medicare rebate(s), and PHI coverage have been applied if eligible. For example, a traditional IVF cycle will include the following fees:

MEDICARE

Medicare rebates are current as of 1st July 2024. Medicare rebates are ESTIMATES only and are subject to change from time to time through Medicare. We recommend that you contact Medicare on 13 2011 to discuss your individual situation. Medicare eligibility and the number of cycles undertaken within the calendar year will determine the actual out-of-pocket expense. As per the legislation, Medicare rebates are NOT AVAILABLE to reciprocal Medicare Cardholders for ART. A reciprocal card is yellow and includes "Reciprocal" on the card.

MEDICARE 30 DAY GLOBAL FEE

Medicare determines that a "Cycle" starts from the day super ovulatory drugs (Follicle Stimulating Hormones) are commenced or from Day 1 of your period (LMP date) and ends after a period of 30 days. This means that any blood tests or ultrasounds performed outside the cycle may result in additional invoices being issued, including invoices for early pregnancy and pathology.

MEDICARE SAFETY NET

The Medicare Safety Net offers additional Medicare rebates when an annual threshold of out-of-pocket costs for outpatient services has been reached. This means you may receive additional rebates on your treatment cycles, reducing your overall out-of-pocket cost. Families and couples are required to register for the Medicare Safety Net whilst registration is not required for individuals. Contact Medicare by phone on 13 2011 to discuss your individual circumstances.

REGIONAL PATIENTS

If you are unable to attend Concept for your arranged blood tests and or ultrasounds and will be accessing these services elsewhere, you will require the necessary pathology and ultrasound request forms to use at our approved external centres. These forms will indicate that you are in an ART cycle and are covered by the Global Fee claimed through Concept Fertility Centre. Our Nurse Coordination team can assist with these forms. Any test or scan completed outside one of Concept's approved centres will attract a separate invoice from the external provider you attend and you will be ineligible for a Medicare rebate.

INTERNATIONAL PATIENTS

Fees are payable in advance for ALL treatment types when a patient is ineligible to receive a rebate under Medicare (including patients with a Reciprocal Medicare card under which ART treatment is excluded). All fees must be paid on the day PRIOR to your procedure. Cancellation fees will apply as per the details on page 7.

INTRODUCTION TO FEES

PRIVATE HEALTH INSURANCE

Private Health Insurance that covers Artificial Reproductive Technology (ART) or In-Vitro Fertilisation (IVF) treatments may reduce or sometimes eliminate your inpatient costs. Any private health insurance excess is payable on the day of your admission to hospital.

International - Medicare does NOT provide a rebate to Reciprocal Medicare Card holders. Refer to page 3 **Surrogacy** - Medicare does NOT provide a rebate if the patient is part of a surrogacy arrangement.

Social Freeze - Medicare does NOT provide a rebate where there is NO medical indication for fertility treatment.

Australian Defence Force (ADF) - MBS item numbers will be billed to the ADF. ADF members will be responsible for payment of non-MBS items.

PAYMENT OPTIONS

The Payment Options listed below only apply to IVF/ICSI, FET, IUI cycle fees.

Fees for Tracking, TICOV and PCT cycles are payable in full.

1. COMPLETE PAYMENT

The complete payment option requires your cycle fees to be paid in full on the day prior to your procedure. Concept will submit your claim to Medicare upon the completion of your cycle. Your Medicare rebate will be deposited directly into your nominated bank account. International patients must choose this option, however will not receive a Medicare rebate.

2. PARTIAL PAYMENT

The partial payment reduces your initial financial outlay. Following your procedure, Concept will submit your unpaid invoice to Medicare on your behalf. Upon receipt of a Medicare cheque this will need to be sent directly to Concept and will be applied to your invoice. Concept will then issue you the balance due (the gap) for immediate payment. The partial payment option DOES NOT apply to patients completing a social freeze nor to patients undertaking a surrogacy arrangement.

3. PAYMENT PLAN

The Concept payment plan is an interest free direct debit service. As with partial payment, your unpaid invoice will be sent to Medicare and the returned cheque must be provided to Concept. This will be credited against your account. A minimum fortnightly payment of \$250 (\$500 minimum fortnightly payment for social freeze and surrogacy) is then debited from your bank account until payment is complete. Refer to page 12 for Terms and Conditions.

4. SUPERANNUATION

Concept can assist by providing quotations for patients who wish to use their superannuation fund for payment of medical expenses, either by independent application (\$150 quotation fee applies) or via a private management service. To discuss this option, please contact our Accounts department. Approved applicants must deposit funds received from their superannuation fund into Concept's account where it will be held as a credit and utilised for payment for IVF treatment. Funds must be deposited with Concept prior to treatment commencing.

IMPORTANT NOTES

INTERNATIONAL

International patients MUST choose Option 1 Complete Payment. Refer to page 3.

SOCIAL FREEZE

Option 2 Partial Payment does NOT apply to patients undertaking a social freeze.

SURROGACY

Option 2 Partial Payment does NOT apply to surrogacy arrangements.

CANCELLATION FEES

Should your treatment cycle be cancelled or result in a failed outcome you will not pay the full cycle fee. Instead, a cancellation fee or reduced cycle fee will apply. These costs are outlined in the table below.

Failed outcomes refer to a failed egg collection or failed oocyte fertilisation. Failed outcome fees are reduced by a certain percentage dependent on the outcome type.

For cancellations, the fees below will apply if the cycle is cancelled after Day 1 of your cycle and prior to the procedure taking place.

The FET/FOT cycle cancellation fee will apply in addition to the fees payable for any pathology or ultrasounds rendered within the cycle. **

Please Note If your IVF / ICSI cycle proceeds to egg collection but for any reason you are unable to proceed to an embryo transfer (ET) with the embryo(s) produced, your next cycle will be an FET, which is charged in accordance with the fee listed for this service on page 5. No discounts apply if an ET does not take place within the IVF / ICSI cycle.

Concept has partnered with Hollywood Pharmacy for all your medication needs. Medications for your cycle are NOT INCLUDED in the cycle fee. Many medications for IVF/ICSI treatments are covered by the Pharmaceutical Benefits Scheme (PBS) and the standard script fee will be charged by the pharmacy. Some medications required for FET, IUI and tracking cycles such as TICOV and PCT are NOT all covered by the PBS.

IMPORTANT NOTES The PBS does NOT cover ART medications for international patients, surrogacy or social freeze patients. Please contact Hollywood Pharmacy directly via phone on 9386 2798 for further advice regarding medication fees.

FERTILITY SPECIALIST FEES

Consultations with the fertility specialist are an external service with an invoice payable on the day to the specialist doctor. THESE FEES ARE NOT INCLUDED IN YOUR CYCLE FEE. The Specialist fees outlined below are NOT Concept charges.

PRE-TREATMENT SCREENING & OTHER INVESTIGATIONS

The fees for these tests are *NOT INCLUDED IN YOUR CYCLE FEE* and additional fees will apply. Examples may include but are not limited to screening bloods and pre-treatment ultrasounds. Some samples are sent offsite to external laboratories for processing and will incur additional fees not determined by Concept.

Some pre-treatment screening bloods attract a Medicare rebate if they are completed outside the 30-day treatment cycle. See Medicare Global Fee on page 3.

Early pregnancy scans will be arranged in consultation with your Fertility Specialist. Additional fees will apply and ARE NOT INCLUDED IN YOUR CYCLE FEE.

There will be no gap for any patient who is with an APPROVED PRIVATE HEALTH FUND. These invoices will be claimed directly from the private health fund.

The private rate detailed below will be charged to UNINSURED patients and patients with a NON APPROVED PRIVATE HEALTH FUND. Once the invoice is paid in full, the patient can submit the invoice to Medicare and their Private Health Insurance Fund for any applicable rebates. Further information is provided on page 4.

TERMS AND CONDITIONS

For this Schedule of Fees, Concept Fertility Centre and Day Hospital will be referred to as "Concept"

- 1. The fees included in the Schedule of Fees may be subject to change without notice.
- 2. It is Concept's responsibility to provide information regarding fees and where out of pocket costs will apply for Concept related services only
- 3. It is the patient's personal responsibility to ascertain the actual fees to be paid, the cancellation fees that may be applicable, the level of Medicare cover and private health insurance fund cover.
- 4. An informed financial consent form is to be signed for treatment requiring theatre services.
- 5. All fees applicable to your cycle will be outlined during your phone consultation with our Accounts team. Please contact them after you receive your treatment orders to ascertain an *estimate* of the fees and charges applicable to your cycle.
- 6. Individual fee consent forms are required to be signed for each treatment cycle.
- 7. Payment options only apply to IVF / ICSI, FET and IUI cycle fees.
- 8. Concept reserves the right to choose the Partial Payment option as your preferred method of payment for a cycle if you have not indicated your preference the day prior to our procedure.
- 9. The Concept payment plan option is debited directly from your nominated credit or debit card through our secure CommBank Bpoint system on an agreed date, beginning no later than the completion of each treatment cycle.
- 10. The payment plan option will be subject to debt management terms. Concept reserves the right to limit the commencement of subsequent cycles based on the patient's total balance of outstanding fees (regardless of previous payment options) which cannot exceed \$9,000 for out-of-pocket expenses. Please speak with our Accounts team prior to commencing a new cycle.
- 11. Failure to pay when required may result in the cancellation of your treatment or procedure, or may hinder the commencement of subsequent cycles for which Concept cannot be held liable.
- 12. Concept reserves the right to charge interest on overdue accounts if any payment is not received within 30 days of invoice. Commencement of further treatment cycles may also be affected.
- 13. An interest rate of 20% will be applied to unpaid accounts that results in transfer to an independent debt recovery agent, who may in turn apply their own fee for collection of the debt.
